ORDER

Kerala is facing second-generation issues with Fecal contamination in the water sources. Even though the state depends on onsite sanitation systems for fecal management, as per the study conducted by Suchitwa Mission, the containment systems seem to be less efficient. Also, the state lacks the periodic desludging of septic tanks. As per the SBM (G) guidelines and to mark compliance with the orders issued by the Honorable National Green Tribunal (NGT) in the case O.A 606/2018, the state committed to construct Faecal Sludge Treatment Plants (FSTP) across the state. To facilitate the Local Self Government Institutions and ease the implementation Suchitwa Mission invited agencies to submit Expressions of Interest (EOI) for empaneling agencies for establishing Faecal Sludge Treatment Plants (FSTP) in Kerala as per ref (1) with the following technologies.

- (1) Upflow Anaerobic Sludge Blanket reactor (UASB) + MBBR/Wastewater treatment
- (2) Anaerobic Baffled Reactor/Digester/Settler+Planted Gravel Filter (PGF)
- (3) Pyrolysis + MBBR/Wastewater treatment
- (4) Vermifiltration
- (5) Mechanical Dewatering + MBBR/Wastewater treatment

The submitted Eols were evaluated as per the criteria stipulated in the notification. The key criteria that are inevitable are listed below.

The firm should have/be

1. Annual turnover for the last three years shall not be less than 1 crore for past three consecutive years within the last 5 years.

2. A Bonafide Indian contractors/Agencies/Organizations, Registered Companies/Firms including Registered Partnership Firms, Proprietorship Firms, Registered Consortiums & valid 'Joint Ventures' and contractors/bidders in India and operating for at least 3 years in India prior to the date of submission of EoI.

3. Have experience in commissioning at least one FSTP in the technology which they are applying for empanelment. Experience in STP construction will be considered with the listed technologies will be considered in case of no FSTP experience.

4. not be blacklisted by the Central/State Government or PSUs.

5. Be a registered firm with a valid Goods and Service Tax number for the line of business the agency is engaged in.
