ORDER

As per the Sanction Orders read as 1st paper above, the Ministry of Drinking Water and Sanitation, Government of India have released a total sum of Rs. 12,47,01,000/- (Rupees Twelve Crore Forty Seven Lakh and One Thousand only) towards the 1st installment of Central Share of Grant- in- aid in the ratio of 60:40 between Central and State respectively for the implementation of Swachh Bharath Mission (Gramin) projects in the State during the financial year 2018-19 as detailed below.

As per the letter read as 2nd paper above Executive Director, Suchitwa Mission has requested to accord sanction for releasing the Central Share of Rs.12,47,01,000/- (Rupees Twelve Crore Forty Seven Lakh and One Thousand only) along with matching State Share of Rs.8,31,34,000/- (Rupees Eight Crore Thirty One Lakh Thirty Four Thousand only) towards the 1st instalment of Grant-in-aid under Swachh Bharat Mission (Gramin).

As per G.O read as 3rd paper above sanction has accorded for the additional authorization of Rs. 4,28,47,000/- (Rupees Four Crore Twenty Eight Lakh Forty Seven Thousand only) under the H/A 2515-789-98 and 2515-796-98 to accommodate the Central release received and also to provide the corresponding State Share under SCP (Special Component Plan for Scheduled Castes) and TSP (Tribal Area Sub Plan) components of the Scheme SBM(G) for the year 2018-2019.

Government have examined the matter in detail and are pleased to accord sanction for the release of Rs.20,78,35,000/- (Rupees Twenty Crore Seventy Eight Lakh and Thirty Five Thousand only) towards the 1st installment of Central Share and State Share of Grant-in-aid (in the ratio of 60:40 between Central and State respectively) for the implementation of Swachh Bharath Mission (Gramin) projects during the financial year 2018-19 as detailed below.
