### ORDER

As per Sanction Orders read as 1<sup>st</sup> paper above Ministry of Drinking Water and Sanitation, Government of India have released a total amount of **Rs.59,36,00,000/- (Rupees Fifty Nine Crore and Thirty Six lakh only)** towards the Performance-based Incentive Grants under Swachh Bharat Mission as part of the World Bank assisted Support Operation based on the result of first round of National Annual Rural Sanitation Survey (NARSS) during the year 2017-'18 as detailed below.

2. As per the letter read as 2<sup>nd</sup> paper above the Executive Director, Suchitwa Mission has requested to accord sanction to release an amount of **Rs.59,36,00,000/-** towards the Performance-based Incentive Grant under Swacch Bharath Mission(Grameen), as detailed above.

3. Government have examined the matter in detail. As per the Guidelines for Performance- based Incentive Grant, the Incentive Grant to the State will be in addition to the funds released to the State for the Annual Implementation Plans (AIP) and will be in the form of 100% Grant from the Centre to States. Therefore Government are pleased to accord sanction to release **Rs. 50.82 crore** under the H/A 2515-101-65-SBM-(01) Central Share(PV), **Rs. 7.49 crore** under the H/A 2515-789-98-SBM-SCP (01) Central Share (PV) and **Rs. 1.05 crore** under the H/A 2515-796-98-SBM-TSP (01) Central Share(PV) (additionally authorized as per G.O. read as 3<sup>rd</sup> paper above). Suchitwa Mission shall provide these funds to Local Self Government Institutions through allotment system through the D.D.O. [Director (Operations)- Additional Development Commissioner, from Commissionerate of Rural Development (on deputation)], declared as per G.O read as 4<sup>th</sup> paper above.
