ORDER

As per Rule 23(1) of the Solid Waste Management Rules 2016, notified on 8th April 2016, every department in charge of local bodies of the concerned State Government or Union Territory administration has to constitute a State Level Advisory Body within six months from the date of notification of the said rules. As per rule 23(2) of the Solid Waste Management Rules 2016, the State Level Advisory Body shall meet at least once in every six months to review the matters related to implementation of these rules, state policy and strategy on Solid Waste Management rules and give advice to State Government for taking measures that are necessary for expeditious and appropriate implementation of these rules

2. As per the letter read above, Executive Director, Suchitwa Mission has requested to constitute a State Level Advisory Body as required by Solid Waste Management Rules, 2016.
